### **Details of Condition of Trade-in Vehicle**

Section 18D(1)(b) *Second-hand Vehicle Dealers Act 1995*

Where a trade-in vehicle is to be traded by the purchaser in connection with the purchase of another vehicle which is subject to a cooling-off period, the purchaser retains possession of the trade-in vehicle during the cooling-off period. Legal title of the trade-in vehicle does not pass to the dealer until expiration of the cooling-off period.

Pursuant to section 18D(1)(b) of the *Second-hand Vehicle Dealers Act 1995*, the condition of any trade-in vehicle to be traded in connection with the purchase of another vehicle which is subject to a cooling-off period, must be recorded.

The details of the condition of the trade-in vehicle must be recorded in the form below and signed by the dealer and purchaser.

The dealer should keep the form and provide a copy of the form to the purchaser.
