

Application for a Producer's Licence Questionnaire

This questionnaire is designed to inform the licensing authority whether an application satisfies the requirements of the Liquor Licensing Act 1997, and to assist with the application process.

Some of the important criteria to be met include:

- The wine was or will be fermented by or under the direction of the licensee;
- The product is uniquely the licensee's own product; and
- The licensee assumes the financial risk of production.

Please note that your responses will be checked by law enforcement agencies. If it is found that you have failed to disclose information required, or have provided false or misleading information in your application, you may be subject to criminal prosecution, disciplinary action and/or licence cancellation.
