Definition of a large Co-operative

A Co-Operative is classified as large if it satisfies two of the following criteria:

- The Co-Operative and any entity it controls, has consolidated revenue of \$8 million or more for the financial year
- The Co-Operative and any entity it controls, has consolidated gross assets of \$4 million or more at the end of the financial year
- The Co-Operative and any entity it controls, has more than 30 employees at the end of the financial year
- A Co-Operative will also be classified as a large Co-Operative for a particular financial year if during that financial year it
 - Issued shares to more than 20 prospective members and the amount raised in that year by the issue of those shares exceeds \$2 million or;
 - Has securities on issue to non-members (other than shares in the Co-Operative or securities issued to former members on cancellation of their membership)

Providing incorrect information

It is a serious offence for a person to knowingly or recklessly make a false or misleading statement or omit information in relation to an annual return. Fines apply.

Fee

The fee to lodge a large co-operative annual return must be paid at the time of lodgement.
