I exercise my absolute discretion under section 81(1)(a) of the Act to determine this matter without holding a hearing.

Ms Smallwood opposes the grant of the application on the grounds that there are already several premises in the area that operate gaming machines and allowing them at this premises will negatively impact to the community. Concerns are also raised in relation to noise late at night from persons coming and going from the venue.

It is important to note that the application is for the transfer of an existing licence from one entity to another entity.

With regards to transferring a licence I am not required to consider section 57 of the Act, which is the requirement for the applicant to satisfy the authority that the operation of the venue will not result in undue offence, annoyance, disturbance or inconvenience to those who reside, work or worship in the vicinity. This is only required to be satisfied at the point the licence is initially granted, or if it is moved to a new address. As the licence in question was an existing licence the authority has already been satisfied of these requirements at some point in the past. This also applies in relation to the gaming machine licence, the licensing authority has already been satisfied that the premises is suitable to conduct gaming operations, and is not required to consider these matters for the purposes of assessing an application to transfer the licence form one entity to the other. Even if the applications to transfer the licence were refused, the licences would still exist they would just remain with the current licensee.

There does not appear to be any valid grounds to refuse these applications and accordingly the applications are granted.

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.
