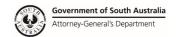

Conditions

The following conditions are added to the licence

- The sale and supply of liquor for consumption off the licensed premises is restricted to the supply of liquor to the commercial residents/tenants/occupants of Lot 14 and only to be consumed within the building of which the licensed premises forms part.
- The exemption from the Responsible Person requirements is granted on the condition that the exemption only applies for events with less than 100 persons. A responsible person or committee member must be contactable by phone at all times the exemption applies.

Authorisations

- Sale of liquor for consumption on the licensed premises authorised
- Sale of liquor for consumption off the licensed premises authorised

Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

It is a requirement under section 97(1) of the Liquor Licensing Act 1997 (the Act) that premises must be personally supervised by a responsible person at all times that they are open to the public, however under section 97(2) of the Act the Commissioner may exempt a licensee from this requirement and approve alternative arrangements for the supervision and management of the business. An exemption can only be granted if the licensing authority is satisfied that, in view of the limited scope of a business conducted under a licence, an exemption would not compromise the principle of responsible service of alcohol and consumption of liquor.

I note that licensee has only sought the exemption to apply for events with less than 100 people only.

Having considered considered the unique nature of the premises, as well as the restrictive nature of their consumption off trade, I am satisfied that, in view of the limited scope of the business conducted under the licence, an exemption from the responsible person requirements can be granted for events with less than 100 persons without compromising the principle of responsible service of alcohol and consumption of liquor. In terms of the alternative arrangements that must be in place in lieu of a responsible person, the licensee will be required to ensure that either a responsible person or committee member can be contacted at all times the exemption is in place. I condition the licence accordingly.

I note that this exemption applies only to the requirement to have a responsible person present at all times, and that

the licensee must still comply with the provisions of the General Code of Practice requiring all persons involved in the sale and supply of liquor to have completed approved responsible service of alcohol training.
