
Submissions from the following persons or corporate entities were received and taken into consideration when determining this application: Annie Elliott on behalf of the City of Holdfast Bay.

dba consistent commercial premises adjacent residential premises (Moseley Square upper floors southern side, Colley Terrace & St Johns Row).

• Capacity to be determined by Private Certifier.

The Act requires me to consider whether granting the application would result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the area. In considering this, I note that there are a number of other licensed premises in the surrounding area of the same licence class that trade until a similar time or later time than what is sought in this application. The Act provides a process should noise become an issue to nearby residents in the future.

I do not deem it necessary to impose conditions prior to the premises commencing trade and therefore am of the opinion that the application should be granted as sought.

In relation to the capacity, it is the Commissioner's position that capacities need not be imposed on licenses of this class, however I note that applicant's obligations to comply with any other laws or regulations that may restrict the capacity of the venue.

#### **Conditions**

#### The following conditions are added to the licence

• The approval to sell liquor in an outdoor dining area shall lapse and become of no effect if the permit issued by the local council lapses, or is cancelled, withdrawn or revoked.


