
# **Community Impact Assessment**

I note that the licensee currently operates under a Restaurant and Catering licence at these premises, which will be surrendered, should this application be successful.

The nature of the proposed business, being an intimate wine bar with a curated wine list, short cocktail list and food offerings, and the demographics of the locality, suggesting it is an affluent area, lead me to form the view that the proposed application does not have the potential to cause significant harm to the community. Further, the applicant currently operates a licensed premises and has demonstrated in their submission an understanding of the relevant rules and regulations in relation to the sale and supply of liquor.

I am also satisfied that this application will not negatively affect the amenity of the locality, and rather will contribute to the vibrancy of this area. As noted in their submission, majority of the licensed premises in the locality operate under a Restaurant and Catering licence, with meals being their primary purpose. The applicant proposes to operate with liquor being the primary service and therefore complement, rather than compete, with other venues in the locality.

Having considered all the information before me, I am satisfied that the granting of this application is in the community interest.

## Conditions

#### The following conditions are added to the licence

• The approval to sell liquor in an outdoor dining area shall lapse and become of no effect if the permit issued by the local council lapses, or is cancelled, withdrawn or revoked.


