#### Capacity

The capacity of the venue is set at 400.



#### **Community Impact Assessment**

The application is a designated application for the purposes of section 53A of the Act.

In order to grant the application I must be satisfied that it is in the community interest to do so taking into account the harm that might be caused, the cultural, recreational, employment or tourism impacts and the social impact on the amenity of the locality. I note that the licensee proposes to operate a high end rooftop complex with beverage and food offerings.

I am satisfied that this venue does not pose a greater risk of harm than any other venue of this nature operating in the locality. The unique set up of the venue, being on the roof top, accessible only be elevator, will allow staff to closely monitor who is entering the venue, as well as reduce instances of at risk groups being exposed to the licensed venue when going about their ordinary day in the vicinity of the venue.

I am also satisfied that, given the number of similar venues in the locality, that this application will not negatively affect the amenity of the locality, and rather will contribute to the vibrancy of this area of the CBD. It will provide an option for the public to attend during the day time with their food offering, and then also provide another option for the public to attend during night time trade to enjoy the entertainment offerings.

Having considered all the information before me, I am satisfied that the granting of this application is in the community interest.
