

### Reasons for Decision

Noble Investment Group Pty Ltd (the Applicant) has applied for a Small Venue Licence pursuant to section 37 of the *Liquor Licensing Act 1997* (the Act) in relation to premises located at 33-37 Wright Street, Adelaide which is to operate under the trading name "Circles". Circles is to be located in the ground floor retail space of the ERGO apartment complex, which is a predominantly residential low rise apartment building, with a number of residential apartments located on the floors above the proposed offering.

The application was advertised with a proposed capacity of 100 persons and trading hours 11am - 2am the following day, 7 days per week and the Applicant initially advised that "the venue will operate as a small boutique bar" (which represented a change of the approved use).

The Licensing Authority (the Authority) received a significant number of objections to the proposal from people residing in the ARGO residential complex, from the Body Corporate Manager of that complex, and from nearby residents who have complained variously that the trading hours sought (to 2am) are too late and will negatively impact on their sleep and quiet enjoyment of their properties. A number of the complainants have expressed concern about patrons congregating out the front of Circles and smoking and feel this will negatively impact their amenity. Concerns have also been raised that the proposal may reduce property values.

Adelaide City Council has provided comment in relation to the proposed business. Council advised that the Applicant would need to operate in accordance with Development Approval 22012660 (DA 2212660) which includes:

- gaming / internet cafe use continuing (not a bar)
- remaining within the hours nominated in condition 4 of the DA (i.e. "hours of operation shall be limited to 10am to 11pm Monday to Thursday and Sunday, and 10am to 12 midnight Friday and Saturday").
- noise controlled in accordance with conditions 2 and 3 (paying attention to addressing recent noise complaints from nearby residents)
- maximum of 2 staff and 30 patrons

The Applicant has confirmed that it is agreeable to proceed on the basis as stipulated by Council and is no longer pressing for a change of use of for hours beyond those approved in the DA. I permit the Applicant to vary their application accordingly pursuant to section 51(3) of the Act.

The site of the proposed premises falls within the Adelaide CBD and is therefore within a "prescribed area" as defined by section 37 of the Act.

I have considered the objects of the Act and requirements of section 57 of the Act, and the concerns raised by residents. In my view it would not be appropriate in light of the location of the proposed venue and objections received to grant a Small Venue Licence with trading hours in line with the trading hours permitted in the DA (10am to 11pm Monday to Thursday and Sunday, and 10am to 12 midnight Friday and Saturday) due to the risk that would pose of the premises causing undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises. In my view the liquor licence trading hours ought to be further reduced than what has been sought in order to address this risk.

I consider it appropriate to grant the Applicant a Small Venue Liquor Licence subject to the following trading rights:

- trading hours are set at 11am 9pm Sunday to Thursday and 11am 10pm Friday and Saturday;
- capacity is set at 30.
