# Reasons for Decision

The licence previously had an exemption on their licence from the requirements to have a responsible person present at the licensed premises at all times pursuant to section 97(1) of the Act.

The threshold to be granted an exemption from these requirements is that the licensing authority must be satisfied that, in view of the limited scope of a business conducted under a licence, an exemption would not compromise the principle of responsible service of alcohol and consumption of liquor. As they have now sought to increase their licensed area and capacity the appropriateness of the exemption should therefore be re-assessed in light of this variation.

The requirement under section 97 of the Act supports the second object of the the Act 'to ensure that the sale, supply and consumption of liquor is undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor.' The principle of responsible service of alcohol is an important aspect of the licensing regime and contributes to overall public safety surrounding the consumption of liquor.

The Act only allows me to grant an exemption where the business carried on under the licence (i.e. the sale and supply of liquor) is of such a limited scope that the premises can be supervised and managed through other means.

I note that the premises will now trade with a potential maximum capacity of 196 persons. Further, the licence class is a liquor production and sales licence with consumption of liquor occurring on the licensed premises. The sale and supply of liquor is not ancillary to some other purpose, it is their primary purpose as they produce and sell liquor. I am therefore not satisfied that the business that will be conducted under the licence (being the sale and supply of liquor) will be of a limited scope.

For this reason, the exemption from the responsible person requirements (and associated condition) are revoked. Therefore, at all times the premises are open to the public the licensee must ensure that a responsible person, or person approved in a position of authority in the licensee entity, are present to supervise and manage the business.


