## Licensee

I note that the applicant will hold the licence as trustee for Jetty Bar Glenelg Unit Trust.

### Transfer

A general and hotel licence in relation to the premises has been transferred to the transferee. I consent to this gaming machine licence being transferred to the transferee.

I am satisfied that to grant this application would not be contrary to the public interest.

The licence is transferred to JETTY BAR GLENELG PTY LTD, Jetty Bar Glenelg Unit Trust effective from 09 Aug 2021.

The licence is transferred, subject to settlement taking place on or before that date. If settlement does not take place on or before that date the applicant must advise this office in writing of the new settlement date.

The transferor is to leave all documentation and signage required to be kept and displayed in the gaming areas pursuant to the Act and Gambling Code of Practice in the gaming area to ensure compliance by the transferee.

## Reasons for Decision

This order supersedes order G105449.

I refer to order B236053 approving the transfer of the associated liquor licence.

Pursuant to section 28 of the *Gaming Machines Act 1992* (the Act) and section 9 of the *Gaming Administration Act 2019* (the GAA), I consent to the transfer of the gaming machine licence on 9 August 2021 on the condition that Mr Craig Bailey and Mr Seth Bailey satisfy the Liquor and Gambling Commissioner, by 1 September 2021, that they are fit and proper persons to occupy positions of authority in the licensee entity. Due to the pandemic, Mr Craig Bailey and Mr Seth Bailey have not been able to undertake fingerprinting for the purposes of assessing their fitness and propriety. To satisfy this office of their fitness and propriety, Mr Craig Bailey and Mr Seth Bailey must undertake fingerprinting, and a copy of their records must be provided to this office, for assessment, by no later than 1 September 2021.

I am satisfied that Carlea Elmes, Karen Bailey, Steven King, David Elmes and Gavin Bailey, who also occupy positions of authority in the entity approved to hold the licence, are fit and proper persons to occupy such a position.

I am satisfied that the grant of this application is not contrary to the public interest.
