## Requirements

The following requirements in support of the application have been satisfied:

- The application has been advertised
- All approvals, consents or exemptions have been obtained

## Premises

### Capacity

- The capacity of the venue is set at 200.
- The capacity of the premises has increased from 100 persons to 200 persons.

## Conditions

The following conditions are added to the licence

- The sale and supply of liquor for consumption off the licensed premises is restricted to - liquor produced by the licensee;- liquor produced by a Shareholder of the licensee or liquor produced by a related entity of the licensee or a shareholder of the licensee.

The following conditions are removed from the licence

- The sale and supply of liquor through direct sales transactions is restricted to .
- The sale and supply of liquor for consumption on the licensed premises is restricted to - liquor produced by the licensee;- liquor produced by a shareholder of the licensee;- liquor of the same type as the product of the licensee or shareholder for the purpose of comparison.
- Liquor of any kind may be sold and supplied for consumption on the licensed premises with or ancillary to a meal or to persons attending a function .

The applicant has applied to increase their trading hours, increase their capacity and vary a selection of licence conditions.

I consider the proposed variations are not contrary to the public interest or inconsistent with the objects of the Act.
