

Reasons for Decision

East End Cellars Pty Ltd (the Applicant) has applied for a general and hotel licence in respect of premises located at 23-29 Vardon Ave, Adelaide, to be known as East End Cellars.


The Applicant presently holds 2 separate licences at the site, a small venue licence (57500132) for premises known as The Tasting Room and a packaged liquor sales licence (57701487) for premises known as East End Cellars. Although the two businesses operate independently, the Applicant states that there is a great deal of cross over between patrons browsing in the bottle shop area and then seeking to consume liquor in The Tasting Room. It was submitted that the 2 different types of licence with different authorisations can cause confusion for customers and difficulty for staff to manage.

It is not proposed to change the current model, other than to operate both businesses under one licence, and surrender the existing licences. The Applicant will continue to operate a wine bar, restaurant and boutique bottle shop with the flexibility to use the entire premises for the different aspects of the business. I note that the bottle shop will be in a defined area and the appropriate endorsement has been sought. The trading hours and capacity will remain the same, consistent with the current building approvals.

Given that the Applicant has been operating this business model at this site for a number of years, (albeit as 2 separate businesses) I am satisfied that there is little or no impact on the community as a result of this proposal. I expect the Applicant will continue to maintain its existing policies and procedures in respect of harm minimisation, such that the operation of the business under a general and hotel licence will pose little risk to patrons or vulnerable members of the
