Premises

New Premises

The licensed area is outlined in red on the approved plan.

Capacity

The capacity of the venue is set at 120.

Community Impact Assessment

The application is a designated application for the purposes of section 53A of the Act.

The requirement to lodge a community impact statement has been waived as I am satisfied that the application does not propose a significant change to the licensed premises or nature or extend of the business carried on from the licensed premises.

Therefore, should the licensee apply to significantly vary the conditions of the licence it is likely that such a variation would be determined to be a designated application for the purposes of section 53A of the Act.

Conditions

The following conditions are added to the licence

- The sale and supply of liquor for consumption off the licensed premises is restricted to the liquor produced by the licensee, Terre A Terre Pty Ltd and liquor distributed by Terroir Selections Pty Ltd.
- Liquor shall only be sold or supplied for consumption on the licensed premises to persons who are seated or attending a pre-booked function or reception.
- The number of functions, where the capacity may increase up to 190 is limited to 6 functions per year.

Authorisations

The following authorisations/restrictions are added to the licence

- Sale of liquor for consumption on the licensed premises authorised
- Sale of liquor for consumption off the licensed premises authorised
