The applicant intends to operate a tea room and wine bar with a full bar offering and the ability to sell takeaway liquor should customers wish to purchase a product they have tried at the premises.

I am satisfied that this venue does not pose a significant risk of harm. The applicant has provided their policies and procedures in relation to the responsible service of alcohol and the area the premises will be located is not at a higher risk of harm.

There applicant has the support of the community and other local businesses due to the premises providing a draw card for tourists and visitors to stop in the town, rather than just pass through. They submit that by drawing customers to the town this will benefit other local businesses as well as supporting local cellar doors by offering their product and exposing customers to these other local businesses.
