Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*.

I refer to my Decision dated 11 April 2022 (attached as a PDF), and note the following matters in addition:

1) The Applicant has confirmed that it consents to the grant of an 'On Premises' Licence instead of the General and Hotel Licence that it initially applied for;

2) The Authority provided the agreement between the Aldinga Bay Surf Life Saving Club Inc and the Silver Sands beach Club Pty Ltd ('the licence agreement') to the Department for Environment and Water to review;

3) The Department for Environment and Water has considered the agreement, and has advised the Authority that it is of the view that the agreement is properly characterised as a licence, rather than a lease, and has confirmed that while Ministerial consent is required (subject to exceptions) under the Crown Land Management Act 2009 for a lease, Ministerial consent is not required for a licence issued in relation to dedicated Crown land;

Consistent with my Decision dated 11 April 2022, and pursuant to s 53(3) of the Act, I hereby waive the requirement for Applicant to file a fresh application for an 'On Premises' Licence.



I grant an 'On Premises' Licence to the Silver Sands Beach Club Pty Ltd.

I approve Mr Nicholas James Stock and Mr Mark Anthony Kamleh to occupy any position of authority in the entity holding the licence.
