

Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*.

I am satisfied that granting a Club Licence to the Tailem Bend Cricket Club (the Club) is consistent with the objects of the Liquor Licensing Act 1997 (the Act) and the requirements in s 36 of the Act, in relation to prescribed matters such as: the Club is incorporated under the Associations Incorporation Act 1985: s 36(5); the Club has exclusive possession of the licensed premises and the Club's rules make adequate provision for the management of the affairs of the club, meeetings, admission of members, the payments of subscriptions by members, and the keeping of proper records of the proceedings of the Club and its financial affairs: s 36(7).

I've considered the matters in s 57 of the Act and am satisfied in relation to the suitability of the premises for the purposes of carrying on the business under the licence. I am also satisfied that the operation of the licence would be unlikely to result in the potential for them to cause undue offence, annoyance and the like to nearby workers, residents and worshippers in their vicinity; or prejudice to the safety or welfare of children attending nearby kindergartens and schools; and that the appropriate planning consents and approvals have been obtained.

SAPOL have not objected to the application.

The Coorong District Council have no objections to the application.

I do not consider that there is any other reason why I should refuse the application under the broad discretion available in s 53 of the Act.

On the material before me there is no reason to refuse the application pursuant to either s 53(1a) or s 53(1b) of the Act.
