### New Premises

## Licensee

- Liquor shall only be sold or supplied to persons who are not involved in shooting or have completed their involvement in shooting.
- The licensee must erect signage at the shooting area stating "Liquor must not be taken beyond this point". The signage is to be clearly visible and unobstructed.
