Licensee

Transfer

The licence is transferred to FLEET STREET SOCIAL PTY LTD effective from 11 May 2022.

The licence is transferred, subject to settlement taking place on or before that date. If settlement does not take place on or before that date the applicant must advise this office in writing of the new settlement date.

Reasons for Decision



In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*. The Licensing Authority became aware that the applicant for the transfer of the restaurant and catering licence had been marketing the business as a cocktail bar, furthermore this had been communicated to the Licensing Authority by the applicant.

Section 35(2) of the Liquor Licensing Act 1997 (the Act), states:

A restaurant and catering licence is subject to the condition that business must be conducted at the licensed premises such that the supply of meals is at all times the primary service provided to the public at the premises, except as otherwise allowed by a condition of the licence.

The Licensing Authority wrote to the applicant's legal representative, Ryan Feuerherdt with concerns the proposed business to be conducted under the restaurant and catering licence may be inconsistent with the specific requirements that apply to a restaurant and catering licence contained in section 35 of the Act.

Mr Feueurherdt responded with submissions that the proposed business to be conducted under the licence would be consistent with section 35 of the Act and that the applicant has provided instruction that the phrase 'cocktail bar' has been removed (or has been instructed to be removed) from all advertising, marketing, and social media.

I note however that there is still some marketing material on line promoting the business as a cocktail bar.

Under section 43 of the Act, I impose the following condition on the licence:

The licensee shall not advertise or promote the restaurant as a bar, cocktail bar or similar.
