

The licensee has applied to remove their licensed premises to 33 Semaphore Road, Semaphore SA 5019.

Pursuant to section 60(1) of the *Liquor Licensing Act 1997* (the Act), I am satisfied that the premises to which removal of the licence is sought are of an appropriate standard for carrying on business under the licence and that the removal of the licence is unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises or prejudice the safety or welfare of children attending kindergarten, primary school or secondary school in the vicinity of the premises.

Pursuant to section 60(2) of the Act, I am satisfied that all approvals, consents and exemptions required under the law relating to planning to permit the use of the premises for the sale of liquor have been obtained and that any other relevant approvals, consents and exemptions required for carrying on the business from the premises have been obtained.

I note that the trading hours have also been amended, with the consent of the licensee, to bring forwarded the consumption on hours to commence at 10am daily, rather than 7am. This amendment was necessary to avoid confict with the development approval which restricts trade at the premises to between 10am and 10pm daily.

The removal application is granted.
