

- The following areas are suspended until further order: The outdoor dining area on the south side of the premises.

Authorisations

The following authorisations/restrictions are removed from the licence

• Sale of liquor in an approved place adjacent to the licensed premises authorised

Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

The licence currently provides authorisation for the licensee to sell and supply liquor in an area adjacent to Shop 6, 121-131 Mawson Lakes Boulevard, Mawson Lakes for consumption in that area.

I note that the City of Salisbury has confirmed the outdoor area is not on council land and therefore does not require an outdoor dining permit to be used.

I further note that the landlord has provided approval for the use of the outdoor area by way of lease.

The authorisation and condition relating to the use of the outdoor area as council land is therefore removed from the licence.

The condition relating to the suspension of a portion of the outdoor area is also removed from the licence as the landlord has provided approval for the use of the area.
