

### Reasons for Decision

In determining this application I have considered the application, submissions from Mr Andrew John, and submissions in reply from the Applicant. I have also considered and have had regard to the objects of the *Liquor Licensing Act 1997* (the Act), as required by s 3(2) of the Act.

I note the submission by the Applicant that they will ensure that the rear door of the premises is not used after 11.30pm any day of the week, so as to reduce the noise to residents who reside to the rear of the premises, and will instead use the front door of the premises (which opens onto King William Street) from 11.30pm onwards. This is an appriopriate concession and on this basis I have decided to grant the hours sought by the Applicant. Had the Applicant not made this concession I would have shortened the trading hours on Friday and Saturday to Midnight.
