

### Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

The application is for the grant of a restaurant and catering licence. The applicant has also sought a condition on their licence to allow them to sell or supply liquor for consumption at the site of a function.

As part of their application, the applicant has addressed the objects of the *Liquor Licensing Act 1997* (the Act) and I am satisfied that the sale, supply and consumption of liquor will be undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor and the expectations and aspirations of the public. The applicant has indicated that all persons employed at the premises will undertake the necessary training with respect to the requirements of the General Code of Practice. I am satisfied that the sale and supply of liquor will occur in a manner that minimises the harm and potential for harm caused by the excessive or inappropriate consumption of liquor.

I am satisfied that the grant of the licence would not be contrary to the public interest or inconsistent with the objects of the Act.

Pursuant to section 56 of the Act, I am satisfied that all persons who occupy a position of authority in the entity holding the licence, are fit and proper persons to occupy such a position.

Pursuant to section 57 of the Act, I am satisfied that the premises for which the licence is sought are of a sufficient standard for the purpose of carrying on business under the licence. Further, I am satisfied that the operation of the licence would be unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises and or to prejudice the safety or welfare of children attending kindergarten, primary school or secondary school in the vicinity of the premises.

Pursuant to section 72 of the Act, I am satisfied that the lessor has consented to the application.

The application is granted. The licence authorises the sale or supply of liquor for consumption at the site of a function off the licensed premises by persons attending the function. The licensee is reminded that the authorisation is subject to the conditions set out in section 35 of the Act that:

- food is provided by the licensee at the function;
- the licensee has been given notice of the function at least 24 hours before the function; and
- the license maintains records relating to the function.

For the duration of any function off the licensed premises, the licensed premise are to be regarded as including the site at which the function is held.
