Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*. The application is for the grant of a restaurant and catering licence.

As part of their application, the applicant has addressed the objects of the *Liquor Licensing Act 1997* (the Act) and I am satisfied that the sale, supply and consumption of liquor will be undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor and the expectations and aspirations of the public.

I am satisfied that the grant of the licence would not be contrary to the public interest or inconsistent with the objects of the Act.

Pursuant to section 56 of the Act, I am satisfied that the applicants are fit and proper persons to hold the licence.

In support of the application, the applicant has provided the licensing authority with a copy of a letter from the City of Port Adelaide Enfield confirming that a Certificate of Occupancy has been issued for the premises and that the hours of operation are not dissimilar to other hours of operation in effect in the locality. Pursuant to section 57 of the Act, I am satisfied that the premises for which the licence is sought are of a sufficient standard for the purpose of carrying on business under the licence. Further, I am satisfied that the operation of the licence would be unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises and or to prejudice the safety or welfare of children attending kindergarten, primary school or secondary school in the vicinity of the premises.

The licence is granted.

The applicant has also applied for authorisation to sell liquor in a place adjacent to the licensed premises for consumption in that area.

Prior to granting an authorisation of this kind, I must be satisfied that the object of the application could not be more appropriately achieved by redefinition of the licensed premises. I am satisfied to that fact. If the relevant place is under the control of council - council must approve the application. A copy of an outdoor dining permit from the City of Port
