

Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

In their application the applicant sought approval for a capacity of 60 persons. However, the Development Approval and certificate of occupancy provided by the applicant permit only a capacity of 40 persons. The applicant has indicated that they will seek approval from the City of Port Lincoln Council to increase the capacity to 60 persons. I allow the applicant 2 months from the date of this order to provide evidence that the City of Port Lincoln Council consents to the increase in capacity. Upon receipt of such evidence, the licensing authority will amend the capacity administratively without the need for a further application.

The applicant also sought approval to vary the trading hours initially proposed in the application, to allow trade until 11:00pm 7 days per week. The licensing authority required the applicant to advertise their amended application for an additional 7 days. I note that the applicant has complied with that request. I am satisfied that to increase the approved trading hours to allow the applicant to trade until 11:00pm on any day would be unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises. I also note that the City of Port Lincoln Council has confirmed they do not have any concerns with the increase to the trading hours.
