On 18 October 2021, the City of Port Adelaide Enfield lodged a submission under section 77(3) of the Act. In the submission the Council has stated that the premises is subject to Development Application Number 040/2122/20. The Development application 040/2122/20 was granted subject to a number of conditions, condition 2 of the approval provides that the hours of operation of the premises shall not exceed the times: 8:00am to 4:00pm.

The applicant has applied for the proposed trading hours of 7am to midnight, Monday to Sunday.

On the 25 November 2021, the applicant supplied to the licensing authority revised development approval from the City of Port Adelaide Enfield dated 1 November 2021. Condition 2 of this approval provides that the hours of operation of the premises shall not exceed the times: Monday to Wednesday 7am to 10pm and Thursday to Sunday 7am to midnight.

Under section 51(3) of the Act I have allowed the applicant to amend the hours of operation so that they are consistent with those in the revised development approval.

I am satisfied that the applicant has the relevant planning approvals under section 57(2) of the Act.

In the submission the Council has also advised that the applicant does not have an outdoor dining permit for the use of the proposed outdoor area sought by the applicant. In addition to this I note that the applicant has not applied to the Licensing Authority for an extension of trading area under 69 of the Act.

Under section 51(3) of the Act, I have allowed the applicant to vary the application to exclude this area from the proposed licensed area.


