

Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*. The applicant has addressed the objects of the Act in their application and I am satisfied the sale, supply and consumption of liquor will be undertaken safely and responsibly, consistent with the responsible service and consumption of liquor, and the expectations and aspirations of the public.

Pursuant to section 56 of the Act, I am satisfied all persons who occupy a position of authority in the entity to hold the licence are fit and proper persons to occupy such a position - noting the further reasons below in relation to Mr Nedal Choujaa.

Pursuant to section 57 of the Act, I am satisfied the proposed premises are of a sufficient standard for the purpose of carrying on business under the licence. Further, I am satisfied the operation of the licence would be unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises and or to prejudice the safety or welfare of children attending kindergarten, primary school or secondary school in the vicinity of the premises.

City of Charles Sturt Council have granted development approval for the proposed venue (a cafe/restaurant fit out) I am satisfied all relevant approvals, consents and exemptions, other than a final certificate of occupancy, are in place.

Pursuant to section 72 of the Act, I am satisfied the lessor has consented to the application.

I am satisfied the proposed licence is not contrary to the public interest or inconsistent with the objects of the Act.

Fit and Proper Person Assessment - Mr Nedal Choujaa

SA Police have lodged a submission pursuant to section 76 of the Act, submitting Mr Choujaa is not a fit and proper person to be approved for a position of authority connected to the licence (a company director and shareholder). SAPOL submitted Mr Choujaa failed to correctly declare his history of offending (criminal and expiation) and that his

history of expiation offences, 36 traffic related expiation offences between 2003 and 2018, are evidence of a deficiency of character.

I have carefully considered SAPOL's concerns but ultimately find Mr Choujaa to be a fit and proper person to occupy a position of authority for a combination of the following reasons:

Mr Choujaa has operated as a person in a position of authority in connection with the sister restaurant, Zayt and Zaatar in Campbelltown, since 2017. I am not aware of any probity issues raised in connection with Mr Choujaa holding this position.

Mr Choujaa's history of offending is largely traffic related and is towards the lower end of the spectrum of concern.

It has been more than 10 years since Mr Choujaa committed an offence (other than an expiation offence) which led to criminal proceedings (a speeding offence from April 2011).

Mr Choujaa has not committed an expiation offence in almost four years, his last expiation offence being a speeding offence in May 2018.

Mr Choujaa provided the following response to SAPOL's submission:

I think there was a bit of a miscommunication and misunderstanding on my behalf,

I currently hold the Following

And in saying that I filled out a P.I.D

To hold a liquor licence in end of 2017 and all my details was lodged to liquor licencing board,

So when filling out this current P.I.D

I continued from end of 2017 so I'm sorry if I filled it out incorrectly, but I wouldn't withhold sensitive and important information intentionally as CBS have all this information previously on hand,

Yes I do have a history with breaking the law when I was young and irresponsible 95 % of my previous offenses were motor vehicle related,

I have done a lot of growing up since then and now have a beautiful family of my own.

I am a very hard working man and sincerely hope my error and misjudgement doesn't complicate my application.


