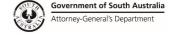

Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

The proposed premises name is Golden Hash, a name which may connote drug-related references. After careful consideration and for the following reasons I do not disallow this trading name pursuant to my powers under section 53(1) of the Act, which gives me an unqualified discretion to grant or refuse an application on any ground for any reason I consider sufficient.

Golden Hash was registered as a business name with ASIC on 24 June 2021. The business has been operating as an unlicensed café/restaurant since 19 July 2021 at the premises on 257 Melbourne Street, North Adelaide.

The menu offers a range of vietnamese food options. The menu also includes various coffees, hot chocolates and teas. The website for the cafe/restaurant also show cases a range of various sweet options including macaroons and cakes. This content is mirrored on their social media page.

The premises is on the ground floor of a multi story building and has a small elevated outdoor area at the front of the premises with plants. The premises is modern and tastefully decorated inside and the front facade of the the premises is modern and appealing.

Upon enquiry by this office, the applicant advised that the name Golden Hash was chosen due to the popularity and use of the hash symbol on social media pages.

A hashtag is used before a word or keyword phrase within a post on social media to help those who may be interested in your topic to be able to find it when they search for a keyword or particular hashtag.

This symbol is used frequently on the social media page for the cafe/restaurant.


