Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

The proposed premises is located within a 'prescribed area' as required by s 37(2) of the Act (i.e.- it is within the Adelaide CBD).

Capacity is to be set at 50 which is well under the Small Venue capacity limit of 120 persons prescribed by s 37(3) of the Act.

I note that SAPOL does not oppose the application, and the Authority has not received any submissions opposing the application. The City of Adelaide Council have granted the necessary development consent.

I do not consider that there is any other reason why I should refuse the application under the broad discretion available in s 53 of the Act.


On the material before me there is no reason to refuse the application pursuant to either s 53(1a) or s 53(1B) of the Act.
