

#### Determination Details

Submissions from the following persons or corporate entities were received and taken into consideration when determining this application: Liz Baines

Mrs Baines has lodged a submission, pursuant to section 77 of the Liquor Licensing Act 1997 (the Act), opposing the grant of this application.

In summary, Mrs Baines grounds for opposing the application are as follows:

Potential noise coming from patrons of the venue

Music being audible outside of the venue

Concerns regarding the space for pedestrians to walk through the outdoor seating area

Concerns with the proposed trading hours of the premises to 1:30am

The applicant has written to the Licensing Authority addressing the concerns raised above. A copy of this response was provided to Mrs Baines.

The Act requires me to consider whether granting the application would result in undue offence, annoyance, disturbance or inconvenience to people who reside in the area, a prominent concern raised by all five residents. The Licensing Court has discussed 'undue noise' on many occasions, with it being held that for the noise to be undue it must be excessive or beyond what is appropriate or natural, and that residents should expect to tolerate a degree of disturbance or inconvenience in the interest of the community having access to a licensed premises. Applying the test in this scenario, I do not believe there is sufficient evidence to conclude that the granting of this application would cause undue noise to nearby residents.

The applicant has sought approval under section 69 of the Act, This provision allows the licensing authority to extend the authority conferred by the licence so that the licensee is authorised to sell liquor in a place adjacent to the licensed premises for consumption in that place.

Section 69(3) of the Act provides that an authorisation cannot be granted under this section unless, if the relevant place is under the control of a council - the council approves the application. The Adelaide City council have provided the applicant with an outdoor dining permit for the use of the area.

As this area is under the control of the council, the council is responsible for the area that is designated for use, setting trading hours for the use of the area and a capacity for the area.

In the applicant's response to the opposing submission, the applicant has noted the concerns regarding the potential noise and music from the premises and has stated:

"we have no approval to play music outside of the venue itself we can't for see an issue with the overflow of music from inside the venue itself. As speakers are fixed internally, there is a tenancy above the absorb external sound leakage. Also ambient street noise occurs from Pulteney Street and Rundle Street and nearby late night venues"

I do not consider the proposed trading hours unreasonable, with trade concluding at 1:30am each night of the week. This is not unusual for a licensed venue on the eastern side of the Adelaide central business district.

After considering the submission lodged by Mrs Baines, I am of the opinion that the application should be granted as sought.
