## Premises

### Removal

The licence is removed to:

8 Corana Court

BALHANNAH SA 5242.

The licensed area is outlined in red on the approved plan.

### Capacity

I remove the capacity of 140 from the licence.

## Conditions

The following conditions are added to the licence

- The licence authorises the sale of liquor produced by the licensee either personally or under contract. Details of all contracts entered into must be available for inspection by an authorised officer.

The following conditions are removed from the licence

- Food shall be available to patrons at all times when liquor is available for consumption.

## Authorisations

### The following authorisations/restrictions are added to the licence

- Sale of liquor for consumption on the licensed premises authorised, but restricted to sampling only

## Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*.

The licensee has sought approval to remove the licence from 2E/43 Onkaparinga Valley Road, Balhannah to 8 Corana Court, Balhannah.

The licensee had been operating a business commonly known as a "cellar door" from 2E/43 Onkaparinga Valley Road, Balhannah. The licensee has sought approval for the licensed premises to be located in a home office at 8 Corana Court, Balhannah.

The licensee has also sought to remove the authorisation which permits the sale of liquor for consumption on the licensed premises.

The licensee's operation of the business under the licence from 8 Corana Court, Balhannah will be limited to a home activity pursuant to Regulation 3 of the Planning, Development and Infrastructure (General) Regulations 2017, I have therefore removed the capacity from the licence.

As the operation of the business has changed significantly I remove the following condition from the licence:

Food shall be available to patrons at all times when liquor is available for consumption.
