Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

It is a requirement under section 97(1) of the Liquor Licensing Act 1997 (the Act) that premises must be personally supervised by a responsible person at all times that they are open to the public, however under section 97(2) of the Act the Commissioner may exempt a licensee from this requirement and approve alternative arrangements for the supervision and management of the business. An exemption can only be granted if the licensing authority is satisfied that, in view of the limited scope of a business conducted under a licence, an exemption would not compromise the principle of responsible service of alcohol and consumption of liquor.

The licensee of the Balnaves of Coonawarra has applied for an exemption from this requirement.

The applicant has submitted the following reasons why they should be granted an exemption:

Second Venue Responsible Person would be at the businesses main premises Monday to Friday during business hours or accessible via mobile telephone 7 days per week. There will not be high numbers of patrons visiting the Tasting Room at any one time. All staff working at the Tasting Room will have Responsible Service Of Alcohol Training and training in the Liquor Licence Risk Assessment and Management Plan.

To grant the exemption, I must be satisfied that the business conducted under the licence is of a limited scope. From



the information provided as part of the application it can be seen that the premises will operate as a winery with a cellar door open to the public. It is therefore quite evident that liquor, more specifically wine, is their primary and predominant purpose. Furthermore, the trading rights granted to the licensee allow them to trade with a significant number of patrons on the premises, being 107, and also late into the evenings, until 2 am each day of the week.

As part of this application the applicant has sought to be able to sell liquor in accordance with section 39 of the Act, without restriction. This means that they can sell and supply:

- Their product for consumption on (in any quantity); and
- Their product, and other liquor of the same type for the purposes of comparison, by way of sample; and
- Any liquor for consumption with a meal they have provided; and
- Any liquor for consumption at a function at which food is being provided; and
- Any liquor for consumption to a person who is seated at a table

They are not being restricted to just samples of liquor, the licence that is being granted to them will allow them to sell full glasses of liquor for consumption on the premises in a wide range of circumstances.

This exemption should not be granted on the grounds of convenience for the licensee. The principles of responsible service of alcohol are of the upmost importance to ensuring public safety and should not be compromised purely to convenience the licensee. Any employee can lodge an application seeking approval as a responsible person with our office, this process is not onerous and does not act as a barrier to ensuring compliance with the requirement to have a responsible person present; it is not difficult to comply with this requirement.

I am not satisfied that the business that will be conducted under the licence (being the sale and supply of liquor) will be of a limited scope. For this reason, the application for an exemption from these requirements is refused. Therefore, at all times the premises are open to the public the licensee must ensure that a responsible person, or person approved in a position of authority in the licensee entity, are present to supervise and manage the business.
