
Conditions

Authorisations

The following authorisations/restrictions are added to the licence

- Sale of liquor by direct sales transactions and the sale of liquor for consumption off the licensed premises restricted to the licensee's product only
- Sale of liquor for consumption on the licensed premises authorised, but restricted to sampling only

Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

The application is for the grant of a liquor production and sales licence which is restricted to the sale of the licensees product only by direct sales transactions. Consumption on the premises is authorised, but is restricted to sampling only. The applicant has addressed the objects of the *Liquor Licensing Act 1997* (the Act) in their application and I am satisfied that the sale, supply and consumption of liquor will be undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor and the expectations and aspirations of the public.

I am satisfied that the grant of the licence would not be contrary to the public interest or inconsistent with the objects of the Act.

Pursuant to section 56 of the Act, I am satisfied that all persons who occupy a position of authority in the applicant entity are fit and proper persons to occupy such a position.

Pursuant to section 57 of the Act, I am satisfied that the premises for which the licence is sought are of a sufficient standard for the purpose of carrying on business under the licence. Further, I am satisfied that the operation of the licence would be unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises and or to prejudice the safety or welfare of children attending kindergarten, primary school or secondary school in the vicinity of the premises. I note that the City of Burnside has indicated that they have no objection to the issuing of the licence and has advised that it is comfortable that the grant of the application would be in line with the existing approved land use of the premises.

I note that another licensed premises is also located at the same premises address, however, as the other premises is granted for a different part of the premises, and the two premises' will be separated by walls, I am satisfied that the provisions of section 48 of the Act would not be offended by the grant of this licence.

The application is granted subject to the conditions and authorisations set out in this order.
