

## **Conditions**

#### The following conditions are added to the licence

- The licensee shall not, as part of, or in connection with, the business authorised by this licence, invite or admit prospective purchasers of liquor to the licensed premises (other than at a site endorsed on the licence).
- The licence authorises the sale of liquor produced by the licensee either personally or under contract. Details of all contracts entered into must be available for inspection by an authorised officer.
- The licensee is authorised to despatch liquor from premises other than the licensed premises. Details of despatch sites must be made available for inspection by an authorised officer.
- The exemption from the Responsible Person requirements is granted on the condition that a licensee must be contactable by phone at all times the premises is open for trade.
- The licensee is authorised to sell or supply the licensee's product for consumption on and off the site of the event endorsement(s) as specified on this licence.

### Reasons for Decision

In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

I note that as the premises will not be open to the public, the responsible person exemption has been applied for to apply only to the site of the event endorsement specified on this licence. As the licensee is restricted to sampling only at these event endorsements, I am satisfied that it is appropriate in the circumstances to grant an exemption from the responsible person requirements and approve alternative arrangements for the supervision and management of the business during these times.
