- The licensee shall not, as part of, or in connection with, the business authorised by this licence, invite or admit prospective purchasers of liquor to the licensed premises (other than at a site endorsed on the licence).
- The licensee is authorised to despatch liquor from premises other than the licensed premises. Details of despatch sites must be made available for inspection by an authorised officer.

Reasons for Decision


In reaching my determination, I have had regard to the objects of the Liquor Licensing Act 1997.

The application is for the grant of a liquor production and sales licence. The applicant has indicated an intention to sell liquor, other than liquor produced by the applicant, for consumption off the licensed premises, including by delivery. The applicant has also indicated that the premises will be used as a 'home office' only.

Under section 39 of the *Liquor Licensing Act 1997* (the Act), the holder of a liquor production and sales licence may sell, at any time through direct sales transactions:

- the licensee's product;
- liquor in an aggregate quantity of 4.5 litres or more;
- liquor by wholesale (i.e. sale to a liquor merchant, being a person who hold a liquor licence in South Australia, other than a short term licence, or a person who holds a liquor licence in another Australian jurisdiction).

The applicant has addressed the objects of the Act in their application and I am satisfied the sale and supply of liquor will be undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor and the expectations and aspirations of the public.

Pursuant to section 56 of the Act, I am satisfied the licensee is a fit and proper person to hold the licence.

The Barossa Council has confirmed they have no objection to the proposed liquor licence provided that the trade undertaken at the premises complies with the definition of 'home activity' set out in regulation 3 of the *Planning, Development and Infrastructure (General) Regulations 2017.*

I am satisfied the grant of this licence would not be contrary to the public interest or inconsistent with the objects of the Act.
