Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*.

I note that this licence is subject to the restrictions set out in section 39 of the Act in relation to the sale of liquor that is not the licensee's product, which are:

- Other liquor can only be sold for consumption on the licensed premises to a person seated at a table, to a person with or ancillary to a meal or to a person attending a function with food.
- Other liquor can only be sold for consumption off by wholesale (i.e. to other liquor merchants) or in bulk quantities, being aggregate quantities of 4.5L or more.

It is also a requirement under section 39 of the Act that at least 90% of their gross turnover for the sale of other liquor for consumption off the licensed premises must be made from sale of liquor by wholesale to other liquor merchants.
