Reasons for Decision

In reaching my determination, I have had regard to the objects of the *Liquor Licensing Act 1997*.

The application is for the grant of a restaurant and catering licence. The applicant, Pattinson Pty Ltd, has addressed the objects of the *Liquor Licensing Act 1997* (the Act) in its application and I am satisfied that the sale, supply and consumption of liquor will be undertaken safely and responsibly, consistent with the principle of responsible service and consumption of liquor and the expectations and aspirations of the public.

I am satisfied that the grant of the licence would not be contrary to the public interest or inconsistent with the objects of the Act.

Pursuant to section 56 of the Act, I am satisfied that Shaun Pattinson and Sheena Pattinson, who occupy positions of authority in the licensee entity, are fit and proper persons to occupy such positions in the entity holding the licence.

Pursuant to section 57 of the Act, I am satisfied that the premises for which the licence is sought are of a sufficient standard for the purpose of carrying on business under the licence. Further, I am satisfied that the operation of the licence would be unlikely to result in undue offence, annoyance, disturbance or inconvenience to people who reside, work or worship in the vicinity of the premises and or to prejudice the safety or welfare of children attending kindergarten, primary school or secondary school in the vicinity of the premises.

Pursuant to section 72 of the Act, I am satisfied that the lessor has consented to the application.

The applicant initially applied for trade between 9am and 11pm daily and a capacity of 50. However, on receipt of the Decision Notification Form from the City of Charles Sturt, the hours for operation were restricted to between 7am to 9pm daily and the capacity was restricted to 30.

Section 11C of the Act states that the Liquor and Gambling Commissioner (the Commissioner) should, in the imposition of conditions under the Act, take reasonable steps to avoid inconsistency with matters that are dealt with or addressed under the *Planning, Development and Infrastructure Act 2016*. The hours approved for trade and the capacity have been amended to reflect the hours and capacity approved by the City of Charles Sturt.

The application is granted, noting that the hours and capacity granted align with the hours and capacity approved by the City of Charles Sturt.
