## Security Agents

### Qualifications

All qualifications must be in the full legal name of the applicant. If you are intending to also operate as a business/body corporate, refer to the Business Criteria fact sheet for additional training requirements.

Note: completion of all 14 core units required to obtain certificate.

#### General Guarding – (Employee)

##### Certificate II in Security Operations (CPP20218)

Note: completion of all 14 core units required to obtain certificate.

#### Body Guarding – (Employee)

**Certificate III in Close Protection (CPPSEC31418)** and completion of the following units of competency:

CHCCCS020	Respond to behaviours of concern
CPPSEC3102	Maintain operational safety and security of work environment
CPPSEC3104	Coordinate monitoring and control of individual and crowd behaviour

#### Guarding with a Dog – (Employee)

**Certificate II in Security Operations (CPP20218)** and completion of the following units of competency

Note: if you already hold a security agent licence for General Guarding or General Guarding as an employee, only the 2 units listed above are required.

No qualification required. Relevant training to be provided by employer.
